In 1868, the American Stud Book created the first standardized thoroughbred horse race betting in the United States, trailblazing an industry that would come to affect almost all people today. From this, gambling boomed in the economy with horse racing leading the way, with over 300 horse racing tracks being built across the United States. In 1910, sports gambling was made illegal once again due to many scandals and fraud. All of that changed once again when Las Vegas legalized betting on sports to boost their tourism industry and allowed the government to collect a 10% tax on all sports bets. This tax almost ruined the industry taking too much money from the casinos and was the lowered to 2% to revive the industry. Congress was opposed to the sports gambling and beginning in the 1960s, worked to establish new laws to slow down illegal sports gambling with no avail, making sports gambling one of the biggest aspects of athletic entertainment by the 1980s. Now in the 21st Century, the industry has seen a boom like no other with online betting and legalization across most states. Results / Conclusions

- Sports gambling studies show the theme of dehumanization of athletes making them seem more like chess pieces than human beings.
- Gambling advertisements have also affected the way that children think of professional sports with studies showing that at least 1/5 of children said they will gamble when they are 18 years old with almost no negative attitude towards it displayed.
- Due to advertisements, commercials, and societal trends, sports gambling has created a toxic environment for sports and feeds on the psychological weaknesses of gamblers.
- With the increased accessibility of placing a bet anywhere in earth where there is internet connection, psychological wellbeing is being targeted and exploited with 64% of pathological gamblers having emotional trauma, 40.5% physical trauma, and 24.3% sexual trauma with a higher dependance on alcohol and attempted suicide.
- Research proves that the legalization of this industry is due to billions of dollars going unregulated and untaxed, forcing the government to change its legislation and get a cut of the profits.

Conclusion

In recent times, we have seen a rise in the social acceptance of sports gambling with sports betting legalized and the birth of online betting.
